- Articles produced by MMV S.r.l. are not defined as substance or mixtures according to Regulation (EC) No. 1272/2008 on classification, labelling and packaging of substances and mixtures (GHS/CLP regulation).
- Depending on the defined alloy (e.g. leaded Brass), MMV S.r.l. articles do contain following substances defined as SVHC in concentrations of more than 0.1% (w/w).
